## **Special Called Meeting Minutes**

July 23, 2024

### **I. Call to order, Pledge of Allegiance & Roll Call**

Mayor Carol Duss called to order the special called meeting of the Bull Shoals City Council Special meeting at 6:30 pm. on July 23, 2024 at 706 CS Woods Dr., Bull Shoals, AR 72619. Recorder Tina Bailey conducted the roll call. Purpose of the Meeting: To address proposed ORDINANCE 2024-02, "AN ORDINANCE AMENDING SECTIONS 1-3 OF ORDINANCE 2014-07 REGARDING RESIDENCY REQUIREMENTS FOR POLICE OFFICERS", dealing with the residency requirement for Bull Shoals City police officers. The proposed ordinance would require officers to live within a 25 mile radius of the Bull Shoals city limits.** Mr. Giannini motioned to read the Ordinance 2024-02 in its entirety and then read by title only for the next two readings tonight and Mr. Castagna seconded. The motion carried 4/1. Mr. Forbus is not participating. Mayor Carol Duss read the Ordinance 2024-02 in its entirety. Mr. Phelan motioned to invoke the emergency clause and Mr. Lindman seconded. The motion carried. 4/1 Mr. Phelan motioned to approve the Ordinance 2024-02 and Mr. Castagna seconded. The motion carried. 4/1 Mr. Phelan motioned to read the ordinance 2024-02 by title only for the second and third readings and Mr. Lindman seconded. The motion carried. 4/1 Mayor Carol Duss read the ordinance by title only for the second reading. Mr. Castagna motioned to approve the ordinance and Mr. Lindman seconded. The motion carried. 4/1 Mayor Duss read the ordinance by title only for the third reading. Mr. Lindman motioned to approve the Ordinance 2024-02 and Mr. Giannini seconded. The motion carried. 4/1

Mr. Giannini motioned to adjourn the meeting and Mr. Phelan seconded. The motion carried and Mayor Carol Duss adjourned the meeting at 7:03 PM.
