

CITY OF BULL SHOALS MARION COUNTY ARKANSAS
ORDINANCE NO 2016-01

AN ORDINANCE ESTABLISHING A BULL SHOALS PARKS AND RECREATION COMMITTEE, ABOLISHING THE CITY OF BULL SHOALS PARKS AND RECREATION COMMITTEE, REPEALING AND REPLACING ORDINANCE 2001-06

WHEREAS, Arkansas State Statutes provide some latitude to municipal governing bodies in the establishment of Parks and Recreation Committees, and

WHEREAS, the City Council, City of Bull Shoals has determined that it is in the best interest of said City to have a Parks and Recreation Committee and

WHEREAS, this ordinance replaces ordinance, 2001-06, and all ordinances or parts of ordinances in conflict herewith are hereby repealed

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Bull Shoals, Marion County, Arkansas that.

SECTION 1 The Mayor, at the first City Council meeting of each calendar year shall appoint, and the City Council of Bull Shoals shall approve, five members to the Bull Shoals Parks and Recreation Committee, provided that nothing contained herein shall prohibit any member from serving more than one term. Members not attending three consecutive meetings may be voted off by a committee majority vote. The Committee will set meeting dates.

SECTION 2. The Committee shall elect a Chairperson by majority vote annually. The Mayor may serve as an ex-officio member of the committee. The Chairperson will provide a monthly report for the Mayor and City Council.

SECTION 3 The Parks and Recreation Committee will provide advice and planning assistance to the Mayor, City Council and Public Works Director.

SECTION 4 All income derived from SECTION 3 shall be deposited in the appropriate City account by the City Treasurer

SECTION 5 The Public Works Department shall perform maintenance of the parks and park facilities

SECTION 6 Fees for Parks and Recreation services shall be established by resolution


SECTION 7 The Parks and Recreation Committee shall submit an annual activities plan and budgetary recommendations to the Mayor and City Council prior to budgetary meetings for consideration

SECTION 8 Ordinances 2001-06 is repealed All previous ordinances or parts of ordinances in conflict with this ordinance are hereby repealed

SECTION 9 If any part of this ordinance is declared invalid or unconstitutional for any reason, such declaration shall not be held to invalidate or impair the validity, force or effect of any other part of this ordinance

SECTION 10 This ordinance shall be in full force and effect from and after its passage

AN ORDINANCE TO REPEAL AND REPLACE ORDINANCE 2004-04 WHICH IS AN ORDINANCE PROVIDING FOR A DEER HUNT (BOW ONLY) IN THE CITY LIMITS OF BULL SHOALS, ARKANSAS

WHEREAS, Ordinance 2001-04 disallows the discharge of a firearm or bow and arrow with the intent to kill any game or bird within the City Limits of Bull Shoals, Arkansas, unless it is in conjunction with regulations promulgated by the State of Arkansas Game and Fish Commission, specifically for the above outlined area, in their constitutional authority to regulate the game and fish population anywhere in the State of Arkansas, and

WHEREAS, the deer population within the City Limits of Bull Shoals, Arkansas continues to be a concern for public safety;

WHEREAS, Issuance of a deer hunt (Bow only) permit was passed by a vote of the citizens of the City of Bull Shoals, Arkansas during the General Election held November 2, 2004, and after it's passage the deer hunt (Bow only) permit was issued to the City of Bull Shoals, Arkansas

THEREFORE, Be it ordained by the City Council of the City of Bull Shoals, Arkansas,

SECTION 1 A regular deer hunt (Bow Only) season will be allowed in the City of Bull Shoals, Arkansas, coinciding with the Arkansas Game and Fish Regular Season, and continuing every year thereafter

SECTION 2. Regulation of deer hunt (Bow only) season in the City Limits of Bull Shoals, Arkansas will be under the auspices of the Arkansas Game and Fish Commission, including but not limited to such issues as bag limit, season length, and penalties for violations

SECTION 3 That it will be the responsibility of the permit holder to properly dispose of any deer that is killed by the permit holder This shall include, but not limited to, the proper disposal of the carcass


SECTION 4 All participants of the City of Bull Shoals, Arkansas, Urban Hunt Program must comply with all policies, procedures, and rules set forth in the Arkansas Game and Fish Urban Deer Hunt application


SECTION 5 Any person who fails to comply with any of the terms and conditions of this Ordinance shall be deemed guilty of a Misdemeanor and subject to a fine of not more than \$200.00 (Two Hundred Dollars), together with restitution to the City of Bull Shoals, Arkansas for the expense incurred for the disposal of the deer

SECTION 6 All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed

SECTION 7 If any part of this ordinance is declared invalid or unconstitutional for any reason, such declaration shall not be held to invalidate, impair the validity, force, or effect of any other part of this ordinance
