A RESOLUTION DECLARING THE HOUSE/STRUCTURE AND GROUNDS COMMONLY KNOWN AS 611 LYNNETTE LOCATED WITHIN THE CORPORATE LIMITS OF THE CITY OF BULL SHOALS, ARKANSAS, TO BE A NUISANCE.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BULL SHOALS, ARKANSAS, that

WHEREAS, the last listed owner of Dwight Arden Williams with the last known address of 3220 Canal Street, Saint Charles, Missouri 63301 and/or, 3331 Rue Royale Street, Saint Charles, Missouri 63301.

WHEREAS, the house/structure and grounds located at 611 Lynnette situated on the following described land in the city of Bull Shoals, Arkansas to-wit;

Lot 9 and the East 45 feet of Lot 10 in Block 68 of the Town of Bull Shoals, as shown by the recorded plat thereof.

WHEREAS, the house/structure and surrounding property complained of is a threat to the health and welfare of the citizens of Bull Shoals, Arkansas, because it has been vacant for several years (city water turned off 11/5/08 for non-payment) and is a haven for rats, mice and other rodents and,

WHEREAS, it is a health hazard because water is permitted to gather in and on places around and in the house/structure and grounds that may provide a place for the breeding of mosquitoes, flies, ticks and other germ carrying insects and,

WHEREAS, because of its vacant and unkempt condition, the premises is a fire hazard that could ignite and spread to other properties causing damage, injury and possible death and,

WHEREAS, the grounds has uncut weeds, garbage, rubbish and other unsightly and unsanitary articles in and about the property and,

WHEREAS, the house/structure complained of is a place frequented by people who may be users of illegal drugs, intoxicants, vagrants, juvenile and/or truants and,

WHEREAS, the deplorable condition of the house/structure and grounds are detrimental to the overall appearance to the neighborhood and the city of Bull Shoals, Arkansas in general and,

WHEREAS, the aforesaid house/structure/grounds are in violation of City Ordinance numbers 2007-07, 2008-02 and others.

THEREFORE, be it resolved that the property described herein is in such condition that same is a health hazard and is unkempt in such condition that same is subject to being condemned and all improvements on said property are in violation of City Ordinances and must be removed forthwith.

BE IT FURTHER RESOLVED that all costs incurred by the City pursuant to this resolution will constitute a lien on said property and same shall be sold to the highest bidder for cash until the City has recovered all costs expended by the City to correct the conditions hereinbefore set out.
