## RESOLUTION NO. 2023 – R - 09

### AUTHORIZING SPECIAL RATES FOR CITY PARKS DURING THE SOLAR ECLIPSE OF APRIL 8, 2024

WHEREAS, the City of Bull Shoals recognizes the significance of the solar eclipse occurring on April 8, 2024, as a unique and rare celestial event; and

WHEREAS, the city is expecting an influx of visitors and tourists to witness this extraordinary occurrence, and it is crucial to ensure the safety and enjoyment of all attendees; and

WHEREAS, the city parks provide an ideal location for residents and visitors to gather and observe the solar eclipse in a safe and communal setting; and

WHEREAS, the City Council finds it necessary to establish special rates for the use of city parks during the solar eclipse event to cover any associated costs and to enhance the overall experience for attendees.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Bull Shoals, Arkansas, as follows:

Section 1: The City Council hereby authorizes the management of city parks to charge a special rate for the use of city parks for the time surrounding the solar eclipse event on April 8, 2024. Special rates for this event shall be incorporated by reference as Exhibit A.

Section 2: The opportunity to charge this special rate shall be applicable for all park facilities and amenities, including but not limited to, picnic areas, pavilions, and other recreational spaces within the city parks.

Section 3: The Parks and Recreation Department is directed to establish and publicize the special rates for the solar eclipse event, taking into consideration the costs associated with event management, maintenance, and additional services.

Section 4: The special rates established under this resolution shall be in effect for the duration of the solar eclipse event on April 8, 2024, and for such reasonable surrounding dates as the city park management deems appropriate and practical.


Section 5: This resolution shall take effect immediately upon passage.

### **CITY OF BULL SHOALS AUTHORIZING SPECIAL RATES FOR CITY PARKS AND CAMPGROUNDS DURING THE SOLAR ECLIPSE OF APRIL 8, 2024**

**Campground Rates for City Parks for Eclipse on Monday April 8<sup>th</sup>, 2024. Rates apply April 5<sup>th</sup> through April 11<sup>th</sup>, 2024.**

- **4 Night Minimum stay.**
- **No Refunds.**

#### **Damsite Park Special Event:**

- **30 Amp - \$80.00/Night (4 Night Minimum)**
- **50 Amp - \$90.00/Night (4 Night Minimum)**
- **Full Service - \$100.00/Night (4 Night Minimum)**
- **Tent Camping Rates same as RV (3 Tents/Site Maximum or 6 persons)**

#### **Point Return:**

- **Cash only.**
- **Tents only.**
- **4 Night Minimum Stay.**
- **\$25.00/Night.**
