RE. **Declaration of Surplus Property – Bluetooth Lapel Mics.**

Please find for your review and deliberation a City of Bull Shoals resolution requesting the declaration of ***Bluetooth Lapel Mics*** as surplus property

This property was purchased last year due to the handheld radios not being able to be used throughout most of the city. The Bluetooth mics connected to the car radio and therefore transmitted and received from the higher power antennas. At the time our working knowledge was that we didn't have a working repeater and thus needed a cheaper fix than replacing the repeater. Now that the handhelds are programmed to use the repeater, we no longer have the need for the Bluetooth mics. The list for the following Resolution is listed as Exhibit 1




